Achieved: Over 20 sections changed in the Punjab Land Revenue Act (1967) and the Punjab Land Revenue Rules (1968) to stop Patwaris issuing manual land records; simplify procedures of issuance and transaction of land records; and establish digital land record processes. The official Punjab Land Records Manual was changed accordingly.

It is working under PLRA Act-2017 and supervision of Board of Revenue, Government of the Punjab. The authority is converting all the manual land records into computerized form for better accessibility and accountability. By computerizing the land records there is lesser room for mistakes and the system will be more transparent.
