There is no limit on the amount Texas landlords can charge as security deposit from which unpaid rent, cost of damage to the unit, charges under the lease and costs incurred by the landlord due to breach of the lease may be deducted. The security deposit or caution fee is the sum a tenant pays at the beginning of the tenancy to cover the cost of repairs for any damage the tenant does on the property.

It is recommended that the tenant appeal to the landlord informally by phone or in person to return the deposit. If this doesn't get results, a demand letter for return of security deposit will be required. The letter should give a clear deadline when the deposit needs to be returned, after which the tenant will go to court.
